Invitation for Sealed Bids for Solar Street Lights @ Shaniarjun Municipality, Jhapa.

Shaniarjun Municipality, Shanischare, Jhapa for Solar Street Light User Committee , Saniarjun invites sealed bids from eligible bidders for the **Design, Supply, Installation, Testing and Commissioning of Solar Street Light.** Qualification requirements include minimum required average annual turnover, experience in similar nature works (Supply, Installation of Solar System equipments such as solar panels, batteries, Solar Street Lights etc.), minimum number of essential equipment, qualification and experience of key professional staffs, minimum amount of liquid assets and/ or credit facilities as specified in the bidding documents. Qualification requirement details can be obtained from Bidding Document.

1. Eligible Bidder's must submit the following document to buy tender document.
 - a) Bidder's Company must be listed in standing list of AEPC.
 - b) Up to date Firm/Company Registration Certificate
 - c) VAT/PAN Registration Certificates
 - d) Tax Clearance Certificate up to **FY 2071/72(2014/15)**

3. A complete set of Bidding Documents may be purchased from the office of Shaniarjun Municipality, Shanischare, Jhapa upon payment of a non-refundable fee of NRs. **1000.00** on or before Bids must be delivered to the Office of the Saniarjun Municipality, Sanischare, Jhapa on or before **3rd september 2016 (18th Bhadra 2073).**
4. All bids shall be accompanied by a valid bid security of an amount not less than the amount as specified below. The bid security guarantee shall confirm to the standard format as specified in the bid document. The bid security guarantee issued by only the commercial bank approved by Nepal Rastra Bank shall be accepted by the employer. If the bidder wishes to submit the bid security in the form of cash, the bidder has to deposit cash in deposit account no: **0600601038334082** of Shaniarjun Municipality, Jhapa in Agricultural Development Bank, Birtamode Branch Jhapa and shall submit bank deposit voucher along with the bid. Bids must be delivered to the Office

of the Saniarjun Municipality, Sanischare, Jhapa on or before 12:00 hrs of 4th september 2016 (19th Bhadra 2073).

5. Bids shall be valid 4th september 2016 (19th Bhadra 2073) and bid security shall remain valid at least up to 3rd January 2017 (19th Poush 2073).
6. Pre-bid meeting will be held in the office of Shaniarjun Municipality Office, Jhapa at 14:00 AM on 27th august 2016 (10th Bhadra 2073).
7. If the specified date for pre-bid meeting, last date of submission and opening falls on a Government holiday then the same time on the next working day shall be considered for such events. In such case the validity of bid security shall be considered from already specified last date for bid submission.
8. Any intimidation, collusion and cartelling during bidding process shall be punishable by law.
9. All other remaining things of the project will be according to prevailing acts and regulations.
