The Shaniarjun Municipality has received a Grant from Government of Nepal towards the cost of Implementation of Development Project and intends to apply part of the funds to cover eligible payments under the contract for Construction of the Commercial Shopping Shutter Building in Sanischare Bajar, Saniarjun-1, Jhapa. Contract Identification Number SM/JHAPA/COMMERCIAL SHOPPING SHUTTER BUILDING 02 /073-74 .Bidding is open to all eligible Bidders.
- 2. Office of Shaniarjun Municipality, Jhapa invites sealed bids from eligible bidders for the Construction of Commercial Shopping Shutter Building in Sanischare Bajar, Saniarjun-1, Jhapa. Eligible bidders may obtain further information and inspect the Bidding Documents at the Office of Shaniarjun Municipality, Shanischare, Jhapa. - 3. A complete set of Bidding Documents may be purchased from the office by eligible Bidders on the submission of a written application, on or before 17:00 hrs 2073/11/20 (3rd March, 2017) along with the copy of company/firm registration, business registration certificate, Vat and PAN registration certificate and tax clearance of fiscal year 2072/073 and upon payment of a non-refundable fee. Payment shall be in the form of cash deposit in office of Saniarjun Municipality, Sanischare Jhapa. If so requested, the Bidding Documents can also be sent by post / courier's services, upon payment of additional non refundable fee of NRS 1,000.00.However, the employer will not be responsible for delay or non delivery of the documents so sent.
- 4. Bids must be delivered to the Office of Shaniarjun Municipality, Shanischare, Jhapa on or before 12:00 o'clock of 2073/11/21 (4th march 2017). Alternatively, bidders may submit their bid electronically through E-procurement section of PPMO's Web Site http://www.bolpatra.gov.np. As specified in the Instruction to Bidders. Late bids will be rejected. Bids will be opened physically and electronically at 14:00 hrs of 2073/11/21 (4th March 2017) after bid submission deadline in the presence of representatives including bidders (who choose to attend) at Office of Shaniarjun Municipality, Shanischare, Jhapa.
- 5. All bids shall be accompanied by a valid bid security of an amount not less than the amount as specified below. The bid security guarantee issued by only the A class commercial bank approved by Nepal Rastra Bank shall be accepted by the employer. If the bidder wishes to submit the bid security in the form of cash, the bidder has to deposit cash in deposit account no: 0600601038334082 of Shaniarjun Municipality Office, Shanischare, Jhapa in Agricultural Development Bank, Birtamode Jhapa and shall submit bank deposit voucher along with the bid.
- 6. Bids shall be valid upto 2074/02/18 (1st June 2017) and bid security shall remain valid upto 2074/03/17 (1st July 2017).
- 7. Pre-bid meeting will be held in the Office of Shaniarjun Municipality, Shanischare, Jhapa at 14:00 hrs on 2073/11/10 (21st Februrary, 2017). Information about submission process of bid electronically (e-submission) shall be provided to all interested bidders who choose to attend the pre-bid meeting.
- 8. If the specified date for pre-bid meeting, last date of submission and falls on a government holiday then same time on next working day shall be considered for such events. In such case, the validity of bid security shall be considered from already specified last date for bid submission.
- 9. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
- 10. All other issued shall be considered as per Public Procurement Act 2063 including latest amendment & Public Procurement Regulation 2064.
